It was also discussed which days A. LaRue will be at the hall this summer like she was last year. A. LaRue has decided that she will be at Friendship Township on the second Friday of the month and be at Readmond Township on the fourth Friday of each month.  
Cheryl True inquired about the website and would like to see it up and running. She is willing to help with it if it is needed.
